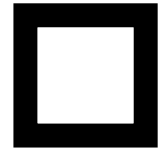

WHISPERS MEMBERSHIP AGREEMENT

Last Revised 5/18/2021

Whispers (aka Whispers Vegas, whispers.vegas, whispersvegas.com, whispers.events & whispers.party) is a private social group by association, online organization conducting private activities on the Internet as a social organization, which hosts regular events, parties, travel trips, and other activities (herein "Event(s)") that is not open to the general public. Group participation is validated by the participation in the online association. Events may be held at private homes, commercial venues, public venues, travel destinations, and other potential locations. Upon entering into this agreement with Whispers all participants executing this agreement agree to the association's rules and policies pertaining to behavior, membership, hygiene, confidentiality, and code of conduct. Whispers hosts Events for those who meet the membership requirements of the online social group sponsored by Whispers which may be held at a private residence or commercial venue.

Private Group by Association/Membership

Whispers is a private members only group by association of which the association is defined as adult couples and adult women who wish to mingle other adult couples, individuals or groups of couples and individuals ostensibly referred to as "Lifestyle Couples". Members are not required under any circumstances to interact with other couples or individuals at any level other than that of a social gathering, communicating amongst other like-minded couples in a positive way. Part of this association also makes it clear that those seeking membership, by signing this agreement state that they are not offended by sexual discussions, partial nudity, nudity, and interactions arising therefrom, but are at no time required to participate in such.

Terms & Condition of Membership

Whispers is a private members only group association and online service provided only for individuals 21 years of age and older for the purposes of communicating online or in person with other adults to develop a network of friends and acquaintances for social reasons. As part of this membership, Whispers provides invitations and access to private parties held at private residences or commercial venues. Any disagreements which arise from this agreement would be adjudicated in Clark County, Las Vegas. As a condition of membership, all members must adhere to the rules, policies, and general code of conduct as set forth by the organizers of Whispers. Such rules, policies, and general Code of Conduct may change without notice. A copy of such rules, policies and general code of conduct is always available upon request. In addition, according to a schedule provided by Whispers, a membership fee is encouraged based on a schedule published on the web site and available from Whispers upon request. To attend Events, a member must be in good standing and in subjective good standing with the general code of conduct. Payments of membership fees are not mandatory. Membership requires that you maintain a valid email account. If you do not have an email account, Whispers shall provide you a whispersvegas.com or other Whispers' managed domain email address free of charge. **Proof of Age must be presented upon signing this agreement in the form of a government issued picture identification. Members may terminate their membership at their choice at any time and for any reason.**

Right to Deny, Suspend or Revoke Membership

Whispers is a private member's only group by association, reserves the right to deny membership at any time for reasons with or without cause. Whispers may also revoke any couple or person's membership without cause. Whispers shall retain the right to suspend any membership on a temporary basis based on the recommendation of the staff, volunteers, Director of Membership, or the Membership Committee.

Privacy & Non-Disclosure

A standing and irrevocable policy of Whispers pertains to the privacy of all parties to this agreement, and which is a specific agreement of non-disclosure. Upon becoming a member or attending an Event as a guest, all parties agree to a strict policy of non-disclosure. Such non-disclosure includes an agreement not to disclose and includes the names of other members who attend Whispers Events, activities which occur at the Event, the location of the Event, and the names of those person(s) hosting the events or volunteering to assist with the organization and execution of the Events. Such non-disclosure also applies to the recording of conversations or activities either by taking digital or film pictures, recording audio, or creating video recordings with or without audio which are strictly forbidden at any time for any reason.

This agreement also is applicable to all forms of digital communications including, but not limited to, websites, e-mails, and information posted on both the group association or Whispers' website, blogs, forums, or other social networking sites whereby all parties executing this agreement agree not to forward, post, repost, or transmit in any digital format, any such materials which is considered private information. As part of this agreement, parties in violation of this agreement are liable for any and all damages caused by such disclosure, including but not limited to attorneys' fees and any costs and expenses associated with the violation of any digitally transmitted, posted, or re-posted copies of any such disclosures. This agreement remains in effect even after the termination or voluntary relinquishment of a membership in order to protect the privacy in accordance with Nevada law of all members and guests.

Venue Policy, Event Policy & Code of Conduct

In addition to this agreement members and guests are expected to adhere to all Event and venue policies and the "Code of Conduct" for all Events. These policies are available upon request and may be subject to change without notice so members should request copies. Notices of change will go out to all members via email and will be printed in the Event Newsletter.

Email Address

A valid email address is required for membership. If you do not have an email address one may be provided for you. This is done both to validate members and to communicate any changes in membership status, changes in policy, or the Code of Conduct.

Storage of Personal Items & Lockers

Lockers as well as a coat closet are available and are used at the member's or guest's own risk. Locks are provided upon request with a \$5 fully refundable deposit. Whispers is not responsible for lost or stolen items of any kind.

WHISPERS CODE OF CONDUCT & VENUE POLICY

Respectful Consent Based Behavior Required

Whisper's Events are for the purpose of consenting adults to socialize in a relaxed and supportive environment. All Members, be they a regular member or volunteers, are expected and required to show all other members **RESPECT** at all Whisper's Events. Unwanted advances; be they commercial, political, sexual, or otherwise, are prohibited and will not be tolerated at any Whispers Event and are grounds for expulsion, possible suspension of membership or termination of membership without refund from an Event.

Privacy

Whispers insists on members and guests signing a membership agreement and adhering to the non-disclosure agreement which is intended to maintain the privacy of all parties. **Cameras or any other recording devices for recording video, audio or still frame images are strictly prohibited.**

Restrictions on Open Carry, Knives, & Other Weapons

No weapons (guns, knives, etc.) of any kind shall be allowed inside of an event under any circumstance.

No Unlawful Activities Allowed

No Drugs Allowed anywhere on the premises, at events on-site or off-site, or used prior to entering the premises. No **Prostitution Allowed** on the premises, at events on-site or off-site, under any circumstance.

Age Requirements

Individuals must be 21 years of age to become a member, to gain access to the property, and to participate in parties or events.

Access to the Property

Whispers reserves the right to deny access to the events, event venues, and public gatherings based on any violation of the Code of Conduct or violation of the Membership & Venue Policy.

Parking

Members and guest shall park only in designated areas. The parking lot is not monitored so please make sure you lock your vehicle. Whispers, event owners, volunteers and staff shall not be responsible for the loss or theft of any personal items left in a vehicle parked on the premises.

Guest Policy

Members are entitled to bring one guest or one couple as a guest as part of their membership if the membership they hold meets the minimum qualification. Members are responsible for the behavior and safety of their guests.

Volunteers

Volunteers are members who are granted a special membership in exchange for assisting in the daily operation of the online group, activities and events on or off the venue. Volunteers must adhere to all rules and the Code of Conduct. Volunteers are selected by the ownership of Whispers. Volunteers are on the premises to assist the event staff in operating the parties and events and to assist guests with their experience and their needs. Members and guests are expected to respect the volunteers and to carry out any reasonable instructions given to them by a volunteer.

Security Volunteers

Whispers may appoint specific volunteer members to assist with the overall security of the property. These volunteers along with the property ownership or event management staff are the only individuals who can demand that a member or guest leave the property immediately.

Couples & Solo Females Only Events

Whispers Events are nominally for **Couples & Solo Females Only**. For members to register as a couple, both members making up the couple must be present during the registration and verification process. Couples must arrive and depart together as a couple. Couples are not expected to remain joined at the hip while attending an event, however they are expected to enter and leave play areas as a couple. **Couples Must Remain Together to Enter the Couples' Areas.** Solo Females are defined as females who want to attend events, parties, or access the property who are doing so alone and not with an accompanying permanent partner **and are not** registered as part of a couple.

Dress Code

It is understood that being focused on summer outdoor activities that the dress code needs to in part reflect this. However, being the goal of the association is to provide a quality experience, a dress code will be enforced for evening parties and events unless the theme of the party warrants a deviation in the dress code. Generally, the dress code restricts members and guests from wearing jeans and shirts without collars. Men are asked to not wear shorts (except around the pool area) or hats of any type. A general guideline is to "dress to impress".

Smoking

Smoking is not allowed inside the premises. Smokers are expected to deposit smoking waste in designated receptacles. There are designated smoking areas outside and around the pool area. This policy includes e-cigarettes, electronic pens, vapes, pipes and cigars.

Use of Alcohol

Event guests and members are allowed to bring their own alcohol for consumption at Whispers events. Guests are responsible for their individual consumption of alcohol. Whispers does not provide alcohol under any circumstance. All alcohol brought onto the property must be taken with the member or guest when they leave. Volunteers or staff are not allowed to handle alcohol at any time, which includes assistance with opening bottles or cans. **Glass containers of any type are not allowed in the pool area, on the dance floor, in the activity rooms or in any other venue area, except in designated areas which are maintained by volunteers.** If you have alcohol in glass containers, a volunteer can provide plastic cups for you to use with your beverage. Bottles left on the premises are discarded at the end of each event. **Over-indulgence is not acceptable and if a member's drinking behaviors become an issue, then that member, or members, will be asked to leave.**

Healthy Environment

A healthy environment is always encouraged. All members should use best practices in maintaining their own health and hygiene, and for the protection of all other member's health and wellbeing. It is up to all of us to provide for a clean and as disease-free environment in all our actions and activities at Whispers Events. Always use all necessary items to prevent the spread of any form of infections/diseases. If at any time you feel you need anything to maintain a disease-free environment, please ask a volunteer for assistance.

Use of the Pool, Hot Tub and Pool Area

Members are encouraged to use the pool, pool area, and hot tub; however, use of these facilities, is at their own risk. The pool and hot tub are clothing optional. Please respect the pool and hot tub area and dispose of all trash in receptacles provided. The property does not provide a lifeguard or safety professional; members, guests, and volunteers use the facilities at their own risks. Members and guests must provide their own towels and sunscreen.

The undersigned understand that activities happening on the premise and being a member have their own risks including but not limited to; medical ailments, injury or death from using the pool, hot tub, or appliances provided, food poisoning, accidents on the property, accidents in route or leaving the property, issues pertaining to the use of alcohol or other intoxicants (with the same not provided by Whispers under any circumstances), incidents involving protesters, lost or stolen items of any kind, and other unforeseen occurrences.

If any journalist seeks to publish a story or an interview about Whispers or any Event activities, he/she must receive approval from both the venue owner and the event management company in advance of publishing said story or interview. Signature below is an agreement not to report on the activities at any Event.

Termination of Membership

Either party may terminate the membership at any time by notification via e-mail or in person at any event.
